REGULAR MEETING ERLANGER COUNCIL February 3, 2015

Mayor Tyson Hermes called the regular meeting of the Erlanger City Council to order in the City of Erlanger Council Chambers at 7:00 P.M., Tuesday, February 3, 2015.

Members of Council and citizens pledged allegiance to the flag.

The following Members of Council were present: Randy Blankenship, Kathy Cahill, Tom Cahill, John Dunhoft, Bill Howard, Vicki Kyle, Gary Meyer, Corine Pitts, Don Skidmore, Renee Skidmore, and Patty Suedkamp. Council Member Kevin Burke was absent.

LEGISLATION – Mr. Wichmann read the second reading of Ordinance No. 2408 amending the text of the Table of Contents and Sections 7.0, 8.2, 9.19, 9.24, 9.26, 9.32, 9.35, 11.3, 17.0, 17.1, and 17.2 of the Erlanger Zoning Ordinance Numbered 1850 to change various terms that are no longer in use to terms now in use; and to clearly define who is the Floodplain Administrator.

Mr. Wichmann read the first reading of an ordinance scheduling the regular meetings of the Erlanger City Council.

Mr. Wichmann read Municipal Order No.02-05-15-01 amending Municipal Order No. 01-06-15-04 to delete the schedule of regular city council meetings in Section 1.1 of the Rules of Procedure thereby adopted.

M/S, Meyer-Blankenship, to adopt the municipal order as read. All ayes, no nays, motion carried.

Mr. Wichmann read the first reading of an ordinance amending the text of the Table of Contents and Sections 8.0 and 13.5 of the Erlanger Zoning Ordinance Numbered 1850 and adding a new section 10.26 to that ordinance to establish a new zone identified as the CS (Commonwealth Station) Zone along with necessary cross-references to other sections of the zoning ordinance.

Mr. Wichmann read the first reading of an ordinance to change the zoning map thereof to re-classify thereon an approximate 42 acre area that is located on the northwest, northeast, and southwest side of the intersection of Commonwealth Avenue and Baker Street, with the reclassification being from the R-1G, R3, PO and SC Zones to the CS (Commonwealth Station) Zone.
