Mr. Wichmann read the second reading of an ordinance amending the text of the Table of Contents and Sections 8.0 and 13.5 of the Erlanger Zoning Ordinance Numbered 1850 and adding a new section 10.26 to that ordinance to establish a new zone identified as the CS (Commonwealth Station) Zone along with necessary cross-references to other sections of the zoning ordinance.

M/S, Dunhoft-Kyle, to adopt the ordinance as read. Eleven ayes (K. Cahill, Suedkamp, Blankenship, Howard, Pitts, T. Cahill, Kyle, Burke, Dunhoft, D. Skidmore, R. Skidmore), one nay (Meyer), motion carried.

Mr. Wichmann read the second reading of an ordinance to change the zoning map thereof to re-classify thereon an approximate 42 acre area that is located on the northwest, northeast, and southwest side of the intersection of Commonwealth Avenue and Baker Street, with the reclassification being from the R-1G, R3, PO and SC Zones to the CS (Commonwealth Station) Zone.

M/S, Howard-Blankenship, to adopt the ordinance as read. Eleven ayes (Dunhoft, Burke, Kyle, T. Cahill, Pitts, Howard, Blankenship, Suedkamp, K. Cahill, R. Skidmore, D. Skidmore), one nay (Meyer), motion carried.

Mr. Meyer voiced concerns with Commonwealth Station ordinances. Discussion took place and answers were provided.

Mayor Hermes questioned whether proper notification was given for the Kenton County Planning Commission's hearings. He asked Mr. Wichmann if he agreed that proper notification was given. Mr. Wichmann advised that he would not.

Mr. Wichmann read Municipal Order No. 03-03-15-01 approving the Fire/EMS Department to apply for the 2015 Safer Grant.

M/S, Meyer-R. Skidmore, to adopt the municipal order as read. All ayes, no nays, motion carried.

Mr. Wichmann read Municipal Order No. 03-03-15-02 making the written determination required by KRS 82.083 for the sale or other disposition of property owned by the city.
