### A CHALLENGE FROM THE FIRE MARSHAL

On behalf of Erlanger Fire/EMS I would like to challenge each family in the City of Erlanger to check each room in your home for these common hazards, and correct them as a basic precaution to protect your home from fire.

Are portable space heaters placed at least 3 feet from anything that can burn?

Are matches and lighters kept in a locked cabinet where children cannot reach them?

Are your electrical cords in good condition, not frayed or cracked?

Do you have a smoke alarm in each bedroom, outside each sleeping area, and on every level of your home?

Are your smoke alarms interconnected so that when one sounds they all sound?

Do you test your smoke alarms once a month?

Does your family practice your home fire escape plan twice a year?

Does your home have an automatic sprinkler system, which will contain the fire?

Does your home have carbon monoxide alarms?

Is your stovetop clean and free from clutter?

Do you stay in the kitchen when you are frying, grilling, or broiling food?

Do you have a sturdy metal fireplace screen?

Do you have your chimney cleaned and inspected at the beginning of each heating season?

Do you encourage smokers to smoke outside of the home?

Do you burn candles in your bedroom? The largest number of candle fires occur in bedrooms

Do you have your heating equipment cleaned and inspected by a professional each year?

If you can answer yes to all or even most of these important fire questions you have improved the overall fire safety of your home. Don't add to the fire statistics in the United States, do your part to protect your family and your home from fire.

# UPDATE FROM THE DIRECTOR OF PUBLIC WORKS

- Bullock Pen Road reopened on August 27, 2008 after a landslide repair project was completed.
- The McAlpin Avenue sidewalk project began September 22, 2008. This will include McAlpin Avenue from Cowie Avenue to Lori Drive, Lloyd Avenue from McAlpin Avenue to Forest Avenue, and Forest Avenue from Lloyd Avenue to Rankin Avenue.
- Bids for concrete street repairs for portions of Elmwood Drive, Carriage Hill, and Northway Drive have been received and work has started on Elmwood.
- Bids for fall street resurfacing have been received and work will soon begin on portions of Sunset Avenue, Elizabeth Street, Place Street, Timberlake Avenue, Hallam Avenue, Concord Drive, Northway Drive, Tracy Jean Lane, Laura Lane, and Jacqueline Drive
- ♦ The annual fall leaf collection program will begin at the end of October. The collection schedule will be available on-line, at the city building, Heritage Bank-Erlanger Branch, Bank of Kentucky-Erlanger Branch, and the Recorder newspaper.

# PROPERTY TAX ANNOUNCEMENT FROM THE DIRECTOR OF ADMINISTRATION

Our tax bills are mailed to the home or business owners. If you have an escrow account with a mortgage company, please contact or forward the bill to them. This way you will know exactly what you are paying for your city taxes.

Taxes are due December 31, 2008. If you have an escrow account, we recommend that you contact your mortgage company prior to that date. To ensure that they pay your bill on time. After January 1, 2009, a 20% penalty will be applied

t o your bill. There will also be a charge of 6% interest per annum. A discount may be obtained by paying your taxes by October 31, 2008.

Tax payments can be mailed by using the envelope enclosed with your tax bill or can be dropped off at the Bank of Kentucky—Erlanger branch or at the city building located at 505 Commonwealth Avenue.

Under the provisions of the Homestead Amendment, a person or persons must be 65 years of age or older or totally disabled during the year for which the application is made, and must own, occupy, and maintain a residential unit for such exemption. If you qualify for a Homestead Exemption and are not currently receiving it, please contact the Kenton County Property Valuation Office at 392-1750. This exemption will save you money on your Kenton County and city taxes.

Money received from tax payments go towards the following: Police, Fire/EMS, Public Works and Parks, Capital Outlay, Administration, Information Systems, and Recreation and Community Development.

#### **CODES ENFORCEMENT NOTICE**

Many cities throughout Kenton County have had to deal with the issue of vicious dogs, specifically Pit Bulls. As of April of 2007, the City of Erlanger has adopted a new ordinance that addresses this issue by setting new standards for those who own dogs that are vicious, or are deemed to be vicious.

Ordinance #2283, which deals with vicious dogs and wolfhybrids, now allows homeowners to own these animals (which include Pit Bulls) as long as they follow certain guidelines. If these guidelines are not met, then the homeowner is considered to be in violation of the ordinance, and the dog must be removed from the property.

A vicious dog is considered to be any dog that is a Pit Bull, wolf-hybrid, or any dog that bites or attacks any human being or other domestic animal without provocation while on public or private property. Erlanger police officers have the authority based on the ordinance to deem a dog as a vicious animal.

If a homeowner's dog meets this classification, they must register the dog with Officer Jouett at the Erlanger Police Department. A copy of the animal's rabies vaccination, as well as proof that the animal has been spayed or neutered and has been micro-chipped is required. Along with those pieces of documentation, the homeowner must be able to provide proof that they have liability insurance on their home for no less than \$100,000.00. Once all of the criteria are met, the dog receives a tag which must remain on its collar at all times.

These guidelines are the more pertinent of the ordinance; there are several more that deal with the animal's restraint while on public and private property. There are also subsections that contain a large list of wild, or exotic, animals whose ownership is prohibited. Copies of the ordinance are available at the Erlanger City Building, as well as the City's website.
