ADOPT A HYDRANT THIS WINTER

The cold and snow season has arrived, so Erlanger Fire/EMS would like to ask that you adopt the fire hydrant located in your yard or nearby. Please take a few extra minutes to shovel out the hydrant when you shovel your walk. Hydrants should have **3 feet of clearance** around them whenever possible, to enable connection of the fire hoses. As always, if you notice a faulty hydrant that appears to be damaged or leaking please contact the Northern Kentucky Water District at (859) 578-9898. The fire hydrants are vital to the operation of the fire department when your house is on fire. If hydrants cannot be located or are buried in snow, it is likely the fire will be much larger.

FIRE PREVENTION UPDATE

This year's fire prevention theme for the month of October was **"Smoke Alarms: A sound you can live with"** as declared by the National Fire Protection Association. Erlanger Fire/EMS began the month with setting up a banner across Commonwealth Avenue and at Brightleaf and Narrows to get the word out to our residents. Our 2010 Fire Prevention Month campaign focused on checking smoke detectors, safety with matches and lighters, and practicing escape plans. We also gave out homework assignments to students to go home and check all the detectors in their house and report back to the t e a c h e r i f a n y we re i n o p e r a b l e.

We presented the fire prevention month theme by hosting firehouse tours, in class presentations, school fire drills and attendance at various Halloween events. These efforts enabled us to reach over 1400 people, utilizing the efforts of in house personnel, and logging over 80 man hours of education efforts. In addition, we handed out 900 silly bandz with firefighting shapes. We also distributed 1500 brochures, 500 stickers, 500 magnets. Overall, it was a very successful year and hopefully the efforts will pay off with a safer community.

NEW FACES IN THE POLICE DEPARTMENT

Due to the retirements this past year of Mark Jolly, Greg Aylor, and Ken Stevens the Police Department has been short staffed. Recently we have hired two new patrolmen to help alleviate this shortage.

Patrolman Scott Russo was hired in July. He spent the next 18 weeks in basic training provided by the Kentucky Department of Criminal Justice Training in Richmond, KY.

Scott is a graduate of Ryle High School and Northern Kentucky University. He received his degree in construction management and worked for a while for Messer Construction. He had initially studied law enforcement and realized that this was the profession he preferred to pursue. Scott is married and has one son. He currently is being trained by other officers in the field training aspect of our department.

Patrolman Adam McGuire was hired in October. Adam came to us from the Airport Police Department and has seven years experience as a sworn police officer. He is a graduate of St. Henry High School and received his Associates Degree in law enforcement from Northern Kentucky University. Adam is married and has 3 children. He also is currently being trained by other officers in the field training aspect of our department.

SUGGESTED DO'S AND DON'T'S OF SNOW REMOVAL

Don't Park on the Street. Move your cars off the street on designated snow emergency routes and especially cul-de-sacs into the driveways when an accumulating snow is predicted. It is difficult to maneuver trucks around on dry pavement let alone in icy conditions.

Do give plows & salt trucks room to maneuver. When applying salt and plowing snow they have to change lanes, back up, and make more frequent stops.

Don't pass trucks when salt is being applied/snow is being plowed. Keeping control of your vehicle can be extremely difficult.

Don't pull out into the intersection when snowplows are approaching. Drivers cannot control the snow coming off the plow blade. The snow often contains rocks and other debris from the roadway.

Don't shovel snow into the street when clearing sidewalks, driveways and parking lots. This makes clearing the roadway more difficult and creates more hazardous patches that require unnecessary retreatment.

Don't cover fire hydrants. If there is a fire hydrant at your curb – do not cover it with snow from your driveway or sidewalk. In the event of a fire emergency - this could help save a life by helping the fire department locate the hydrant more quickly.

Do be patient. When snow plow drivers clear residential streets; their plows **will** throw snow to the side and sometimes unintentionally into the entrances to driveways. This is an inconvenience that is unavoidable and always unintentional.

SNOW PROCEDURES

When inclement weather hits, the ten person operations staff of the Erlanger Public Works Department breaks down into two five person shifts to tackle conditions to the best of their abilities with the resources that they have available. They utilize four "work zones" during snow removal operations. With the 120 plus lane miles that they are tasked with taking care of, their target goal is to assign five trucks to the designated routes in the four work zones. Zones 1-3 have one truck assigned to the respective route in that zone and Zone 4 is divided into two routes (because of size) with one truck assigned to each respective route. They **do not** take care of **private drives or streets** within any portion of the city.

Within each zone are designated snow emergency routes that parking is prohibited on when a snow emergency is in place. By City of Erlanger Ordinance, a snow emergency can either be declared or is automatically in place whenever there is an accumulation of snow or ice upon any portion of designated snow emergency streets in excess of two inches in depth. For the list of designated **snow emergency routes**, please visit the Public Works Department page on our website. To find out whether a snow emergency has been declared please view the school closing listings on Channels 5, 9, and 12, or go to our website or Facebook page. Vehicles that are not removed off designated snow emergency streets will be ticketed. The fine is \$25.00 which will double to \$50.00 if not paid within 7 business days. Our priority is not the income received, but to get the vehicles removed so that the streets can be addressed.

LOCAL GOVERNMENT UPDATE

The City of Erlanger operates under a Mayor-Council form of government and is a 3rd class city. Because of this class ranking, this allows Erlanger to have a twelve member Council. There are ten veteran Council Members returning for a two year term this year and two new faces joining them. Your 2011-2013 Council Members are: Randy Blankenship, Jim Brown, Kevin Burke, Tom Cahill Jr., John Dunhoft, Bill Howard, Stephen Knipper, Vicki Kyle, Shane Longshore, Corine Pitts, Renee Skidmore, and Patty Suedkamp. Long term Council Members Jim Burger and Keith Henry both moved out of Erlanger in 2010 making them ineligible to continue to serve on Erlanger's City Council. Mayor Thomas Rouse returned as the Mayor for a term of four years, 2011-2014.

The Mayor is the Executive Branch of local government. He enforces the Mayor-Council plan, city ordinances, orders, and all applicable statutes. He supervises all departments of city government. He has the authority to appoint and remove all city employees. The mayor facilitates the monthly Regular Council Meetings held on the first Tuesday of every month, the Council Committee Meetings that may be scheduled on the other Tuesdays of the month, and any Special Council Meetings or Public Hearings that are scheduled.

The Council Members are the Legislative Branch of local government and because Erlanger operates under a Mayor-Council form of government, they must act only as a whole body, meaning that individual Council Members may not act or make decisions on behalf of the whole Council. The Mayor-Council form of government gives all legislative authority to the Council Members, unless there is a tie. In that instance, the Mayor can vote as a tie-breaker.

SOLICITATION IN ERLANGER

The City of Erlanger has a **No Knock Policy**. In 2002, City Council voted on an ordinance that established regulations for uninvited solicitations of contributions, sales of goods and services, pledges, subscriptions, orders, and offers and established penalties for the violation of this ordinance. The City then set up a program for those residents who did not wish to have solicitors visit their home. We continue this program today. If you do not want solicitors knocking on your door, please visit the City of Erlanger at 505 Commonwealth Avenue. You will be required to complete an Anti-Solicitation Registration form that will be kept on file. Your address will be added to a list of others that cannot be solicited at. This list will be provided to Solicitors when they register at the City to solicit.

Anyone wishing to solicit in the City of Erlanger must register at the Erlanger City Building. All interested solicitor applications are reviewed by the Police Department before approval is given. Once the solicitors are given permission to go door to door, they are given the list of addresses they cannot go to and a copy of their application showing that they were given approval. Both these items must be on them when they solicit. If someone is going door to door in your neighborhood and does not have the paperwork with them, goes to your door when they are not supposed to, or are acting suspicious, please contact the Erlanger Police Department. Please do this immediately so that the Police Officer responding has the opportunity to locate the person(s) before they leave your neighborhood.
